A growing partnership between agriculture and major food services in Polynesia

FRIDAY, 20 JANUARY 2012

Newrest Group management, represented by Olivier Sadran and Jean-Paul Llanusa, and executives from Newrest-French Polynesia, Bernard Mauze and Emmanuel Leprêtre, met the Minister of Agriculture yesterday evening. Newrest Group expressed its commitment to the development of local agriculture. Olivier Sadran indicated that the economic environment has led the Group to make the following observations:

- 1) The economic environment is heading towards even greater complexity. Importing, with the rise in the price of a barrel of oil, is causing an increase in the price of imported products.
- 2) The crisis that households and communities are facing has caused unemployment and families can no longer pay for their children's meals at school. This is a real problem for subsidized meals and one that cannot continue.
- 3) Local production creates jobs and is a true solution to boost the economy in Polynesia.

After a few hours of discussion, an agreement was reached on the conduct of a test based on specifications involving three or four products in an initial stage. Newrest has agreed to participate in storage and buffer zone projects. The issued of mixed cargoes must also be examined. The Minister of Agriculture has invited the Newrest Group to attend future meetings with agricultural groups and other providers.

The rights to the engineering and construction of the first electric train of the Peruvian capital have been won by the joint-venture Consorcio Tren Electrico Lima, this train will be at the forefront of the efforts made to modernise public transport in a city suffocated by traffic and pollution. This joint-venture ensues from the strategic association of two construction leaders in Peru, Odebrecht Perú and Graña y Montero. This project will facilitate the travelling and safety of over 3 million residents of Lima on a daily basis.

In order to meet the needs of feeding the administrative staff and those involved in operational activities, Newrest has installed and has taken over the management of the kitchen and canteen in the base camp. Furthermore, the delivery of sandwiches, drinks and meals to engineers and workers working along the line under construction is also planned. From March 2012 onwards, the meals will be served daily during the entire duration of the project, which should last 27 months.

With this new contract, Newrest confirms it's ambition of expansion and it's long-term commitment to the people engaged in construction, in the Lima region as well as in the province. We wish to thank Odebrecht Perú and Graña y Montero for the confidence they have placed in our company.

We will gradually be catering for the night stop over flights in Nice, Toulouse, Lyon as soon as the program is completed and the new service on board the flights is set up.

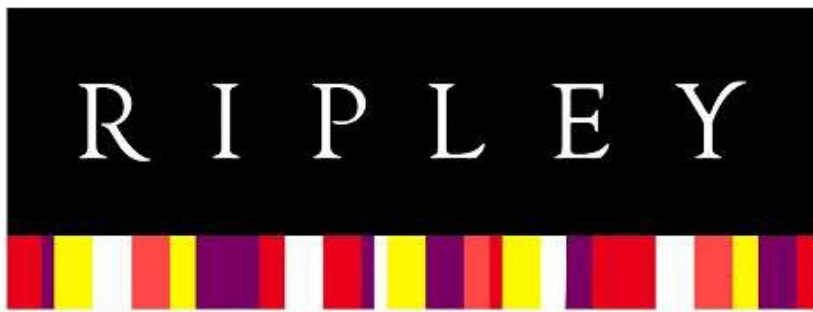

Successful introduction of Newrests Saudi Airlines Catering on the Riyadh stock market

July 9th, 2012 (Toulouse, France): Saudi Airlines Catering (“SAC”) listed 30% of its Capital, for a value of ~350 m€ (~280m€) on the Saudi Riyadh capital market on 9 July, 2012; the value was at the high end of the expected price range level. The stock offering was oversubscribed approximately 6 times between institutional and retail investor demand.

Created in 1981, Saudi Airlines Catering has activities in airline catering, sales on board, collective catering, remote site services and hospitality services with turnover of 390m\$ (312m€) en 2011. SAC served more than 26 million meals in 2011, mainly emanating from Jeddah, Riyadh, Dammam and Medina. Major clients include Saudia Airlines, Air France-KLM, British Airways, Lufthansa, Cathay Pacific, Royal Air Maroc as well as Aramco, SABB HSBC, Maadhen et the University of Princess Nora (37.000 female students). SAC has more than 3300 employees of which more than one third are Saudi nationals, a ratio which places SACC in the highest category of local employment in the kingdom. SAC with the support of Newrest has also been a major driver in increasing the local employment of women in the country as initiated by His Majesty the King of Saudi Arabia, and now employs more than 150 women in the company.

Over a field of more than 70 bidders, Newrest Group and its consortium with Al Hokair Group and Injaz, won the privatization of SAC by Saudi Arabian Airlines Group in 2007. Newrest, as the managing technical partner of SAC and significant shareholder, through internal improvement programs, development of new activities, technology and industry expertise, Newrest has been able to support SAC in increasing its revenues by 75% since 2008, with net profits rising 225% over the same period [102m\$ (81m€)].

Newrest and its partners in SAC will continue to follow its strategy to expand our catering activities in SAC through all sectors of catering [airline, retail, buy-on-board, train, healthcare, education] and support services [remote site, mining, laundry, staff accommodation] in Saudi Arabia and the GCC.

Jonathan Stent-Torriani and Olivier Sadran co-CEOs of Newrest said: “The success of this Initial Public Offering confirms that Newrest’s approach to develop airline catering subsidiaries in partnership with parent national airline companies and local investors is a win-win strategy. We believe that our know-how, our knowledge of the sector and the region will allow Newrest to enter into similar partnerships in the future with as much success.”

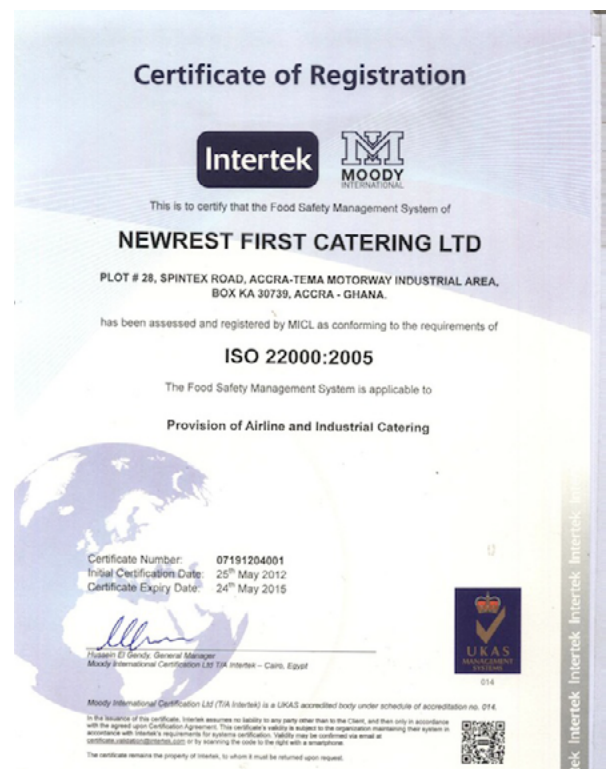
Accra awarded ISO 22000:2005 certification

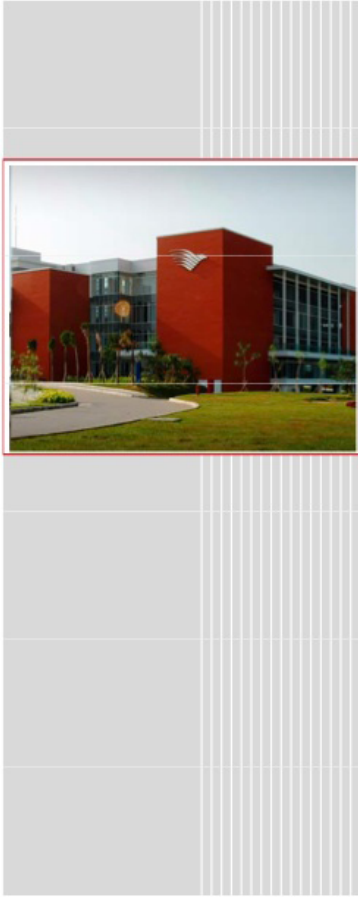
